Quarantine Survey for 12th Festival of Pacific Arts in Guam

National quarantine is the first line of defense against the introduction of exotic pests and diseases. Many Pacific Islanders and people from beyond the region will be travelling to Guam to take part in the 12th Festival of Pacific Arts in 2016. Plants and plant products, and animals and animal products are prohibited items if they are not properly prepared and Festival delegations are asked to make sure they know what is allowed and what is not allowed into Guam. Quarantine cannot be compromised and any item that does not meet quarantine requirements will not be allowed through.

We want to minimize the chances of new pests and diseases 'hitch hiking' on the luggage and hand crafts of travelers en route to Guam. Your answers to the short questionnaire below will facilitate quarantine clearance of your national delegation. We therefore ask you (national delegations) to complete this survey about the products you will be bringing to Guam. The information you provide will enable us to undertake the necessary risk analysis to identify items that are prohibited, and put in place strategies to minimize the movement of pests, and still maintain the essence and beauty of the Pacific's premier cultural event.

Your responses will be very valuable to us:

1. List all plants and/or plant products (flowers/leis, medicinal plants, wreaths, kava, carvings, traditional costumes, handicrafts, thatching). For fresh plants, leaves and flowers, please state the local name and if possible, the scientific name. Your ministry or department of agriculture can assist with the scientific names.
